AT A REGULAR MEETING OF THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH, NEW YORK, HELD SEPTEMBER 13, 1962.

BY ALDERMAN FLYNN; SECONDED BY ALDERMAN SABOURIN:

LOCAL LAW NO. 8 OF 1962

ENTITLED AN ACT CREATING A CIVIC CENTER COMMISSION, PROVIDING FOR ITS MEMBERSHIP AND PRESCRIBING ITS POWERS AND DUTIES.

BE IT ENACTED BY THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH, NEW YORK, AS FOLLOWS:

SECTION 1. CREATION OF COMMISSION. THERE IS HEREBY CREATED IN THE CITY OF PLATTSBURGH A COMMISSION TO BE KNOWN AS THE CIVIC CENTER COMMISSION, WHICH SHALL CONSIST OF ELEVEN (II) MEMBERS, WHICH, UPON CREATION, SHALL CONSIST OF FIVE (5) PERMANENT MEMBERS AS FOLLOWS: WILFRID D. CRETE, ARTHUR H. CRETE, JOHN J. TYRELL, CLYDE A. LEWIS AND JOHN J. SLATTERY, 2ND. THE SAID JOHN J. TYRELL SHALL SERVE AS PERMANENT CHAIRMAN OF SAID COMMISSION UNTIL HIS DEATH OR RESIGNATION. THE ADDITIONAL SIX (6) MEMBERS SHALL BE APPOINTED BY THE MAYOR, SUBJECT TO THE APPROVAL OF THE COMMON COUNCIL, FOR A TERM OF FIVE (5) YEARS, COMMENCING SEPTEMBER 15TH, 1962.

Upon a vacancy occurring among the permanent members of the Commission, a successor shall be appointed for a period of five (5) years. Upon a vacancy occurring in the office of the permanent chairman, the members of the Commission shall choose a Chairman from their own numbers. The Commission shall choose its own Secretary, and the City Chamberlain shall be the Treasurer of such Commission, and all moneys held by him shall be held in a separate account.

SECTION 2.A POWERS AND DUTIES. THE SAID COMMISSION SHALL HAVE THE FOLLOWING POWERS:

- (A) TO ACQUIRE LAND IN THE NAME OF THE CITY OF PLATTSBURGH FOR THE ERECTION OF A CIVIC CENTER.
- (B) TO PREPARE PLANS WITH THE ASSISTANCE OF ARCHITECTS AND ENGINEERS FOR A CIVIC CENTER.
 - (c) To construct a CIVIC CENTER WITHIN THE CITY OF PLATTSBURGH.
- (D) TO EXPEND SUCH MONEYS AS MAY BEAPPROPRIATED TO THEM FOR THIS PURPOSE BY THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH, AND TO RECEIVE AND EXPEND ALL SUCH MONEYS AS MAY BE RECEIVED BY SAID COMMISSION, EITHER BY GIFTS OR BY BEQUESTS, OR FROM INCOME FROM THE SAID CIVIC CENTER, OR ANY INCOME FROM ANY OTHER SOURCE.
- (E) TO ACT AS TRUSTEES FOR ANY FUNDS WHICH MAY BE RECEIVED FROM PRIVATE SOURCES FOR THE MAINTENANCE OF A CIVIC CENTER, WITH THE RIGHT TO INVEST AND REINVEST AT THEIR DISCRETION, UPON A TWO-THIRDS VOTE OF THE COMMISSION.

- (F) TO HAVE EXCLUSIVE CONTROL AND MANAGEMENT OF SAID CIVIC CENTER.
- (G) TO MAKE RULES AND REGULATIONS GOVERNING ITS PROCEEDINGS AND ALSO GOVERNING THE OPERATION OF SAID CIVIC CENTER.

SECTION 3. LAWS OR ORDINANCES IN CONFLICT WITH THIS LOCAL LAW ARE HEREBY SUPERCEDED.

SECTION 4. TIME OF TAKING EFFECT. THIS ACT SHALL TAKE EFFECT AFTER PUBLIC HEARING AND APPROVAL OF THE MAYOR.

ON ROLL CALL, ALDERMEN BOOTH, BEAUVAIS, QUINN, SABOURIN AND FLYNN VOTED IN THE AFFIRMATIVE; NO ONE IN THE NEGATIVE; (ALDERMAN BRANON BEING ABSENT) CARRIED.
