#### CHANGES TO THE PROJECT MANUAL

#### 3.01 REVISED SECTIONS

- A. **REPLACE** Section 00 4100 Bid Form: Use attached updated bid form revised to include add/deduct unit pricing for glycol disposal and installation above/below the estimated quantities.
- B. REPLACE Appendix B Summary of Equipment to be Provided by Owner & Installed by Contractor: Attached is an updated equipment quotation from F.W. Webb which includes corrections of HWP-3,4 to 115v power supply and 1-1/2" flange size. The attached quotation also includes purchase pricing for the equipment to be supplied by Owner.

#### CHANGES TO THE DRAWINGS

#### 4.01 REVISED DRAWINGS

- A. REVISE Drawings M001 DPW Mechanical Notes & Schedule and M011 HEO Mechanical Notes & Schedule: Change Equipment by Owner Notes, note #2 reference to F.W. Webb quotation to the attached version dated 06/23/2021.
- B. **REVISE** Drawing M011 HEO Mechanical Notes & Schedule: Delete row BF-1 from the Mechanical Equipment Schedule as no bypass feeder will be required in the HEO Shop.
- C. **REVISE** Drawing M111 Enlarged HEO Existing/New Utility Room Plan:
  - 1. Delete the New Bypass Feeder BF-1 and associated branch piping, valves, and drain from the New Boiler Schematic.
  - 2. Add to Enlarged New Utility Room Plan a label at the termination of the new boiler vent/intake piping to extend the vent/intake openings and terminate no less than 3 feet above the existing air intake louver on the exterior of the building.
- D. REPLACE Drawing G001 General notes: The attached drawing replaces the original G001 and now includes a detail to revise and replace the labels on drawings M101, M102, and M110 regarding the scope of work for replacement of the air vents at each existing unit heater assembly.

#### GENERAL PRE-BID MEETING QUESTIONS AND ANSWERS

### 5.01 RESPONSES

AEDA PROJECT #21031

### A. CLARIFICATION

<u>Question</u> – Is the Contractor responsible for disposal of the existing glycol containing solution, and if so what is the estimated volume?

<u>Answer</u> – Yes, the Contractor shall dispose of all existing glycol containing solution in a manner according to applicable regulations. Based on observed pipe lengths and sizes, it is estimated there is approximately 740 gallons of solution in the DPW Garage and 70 gallons of solution in the HEO Shop, for an approximate total volume of 810 gallons.

#### B. CLARIFICATION

Question – Are the control systems and electrical work part of the Contractor's scope? <u>Answer</u> – Yes, all electrical and control system work is part of the contract. The pumps HWP-1,2 and HWP-3,4 currently operate with one pump running 24hr/7days and are alternated manually. The new controls shall provide a scheduler feature for the Owner to alternate pump operations with the computer interface per System Control Notes on drawings M001 and M011.

### C. CLARIFICATION

Question – Will the boiler and pump concrete pads remain? Answer – Yes, please see Mechanical Scope of Work Summary / Demolition Work note #7 on drawings M001 and M011 for cleaning and removal of existing anchor requirements.

### D. CLARIFICATION

Question – Do the existing pump starters need to be replaced or can they be reused? <u>Answer</u> – If the existing pump starters are adequately sized for the new HWP-1,2,3,4 and are compatible with the required System Control Notes operating/monitoring requirements as indicated on drawings M001 and M011, then the existing starters can be reused. If not, the Contractor shall furnish and install new pump starters as outlined in the project drawings.

#### E. CLARIFICATION

<u>Question</u> – Will the unit heater thermostat replacement require any painting of walls? <u>Answer</u> – No the Contractor will not need to paint any walls behind the new thermostat installations.

## F. CLARIFICATION

<u>Question</u> – Are unit heater air vent replacements manual or automatic?

<u>Answer</u> – The proposed air release replacement at each unit heater was indicated to be manual air releases on the project drawings, however per the attached G001 drawing and the added schematic, the new air releases shall be automatic with new ball valve blowoff. All unit heaters are to remain.

#### G. CLARIFICATION

Question – Is a glycol injection system required?

<u>Answer</u> – No, the Contractor shall utilize temporary means & methods for glycol delivery into piping system.

#### H. CLARIFICATION

Question – What are the normal work day hours?

<u>Answer</u> – The facilities are regularly occupied 7am to 3pm, the Owner will provide access to all work areas as needed and can accommodate later work hours as required.




