

USE VARIANCE CRITERIA

No such use variance shall be granted by the zoning board of appeals without a showing by the applicant that applicable zoning regulations and restrictions have caused an "Unnecessary Hardship." In order to prove such unnecessary hardship the applicant shall demonstrate to the Zoning Board of Appeals that for each and every permitted use under the zoning regulations for the particular district where the property is located:

- (1) You must prove a lack of reasonable return. Please provide competent financial evidence which proves a lack of reasonable return.

We are not able to rent the bottom floor as an office offered at \$800 per month. There has been zero interest since advertised. We are able to rent the bottom floor as a 2 bedroom apt. for \$1300.00. There is demand for this location as an apartment; however, to date there is no interest in this space as an office rental.

- (2) Please demonstrate why your hardship is unique to your property and does not apply to a substantial portion of the neighborhood.

This building is set up as a 3 unit building in a residential area. Nothing would be altered to the building and it would actually provide less traffic on the street and to and from the building if converted to a 3rd apartment.

- (3) Please show that granting this use variance will not change the essential character of the neighborhood.

Absolutely nothing would change to the neighborhood and the building. In fact, fewer cars would be in and out of the area and fewer people would be in and out of the building.

- (4) Please demonstrate why the alleged hardship has not been self-created

We purchased this building, perhaps ignorantly assuming we would be able to utilize this building as 3 apartments. Three units would yield a reasonable amount for the owners' retirement. If they are unable to utilize this space as a 3 unit apartment building then they will face a financial hardship from this investment.

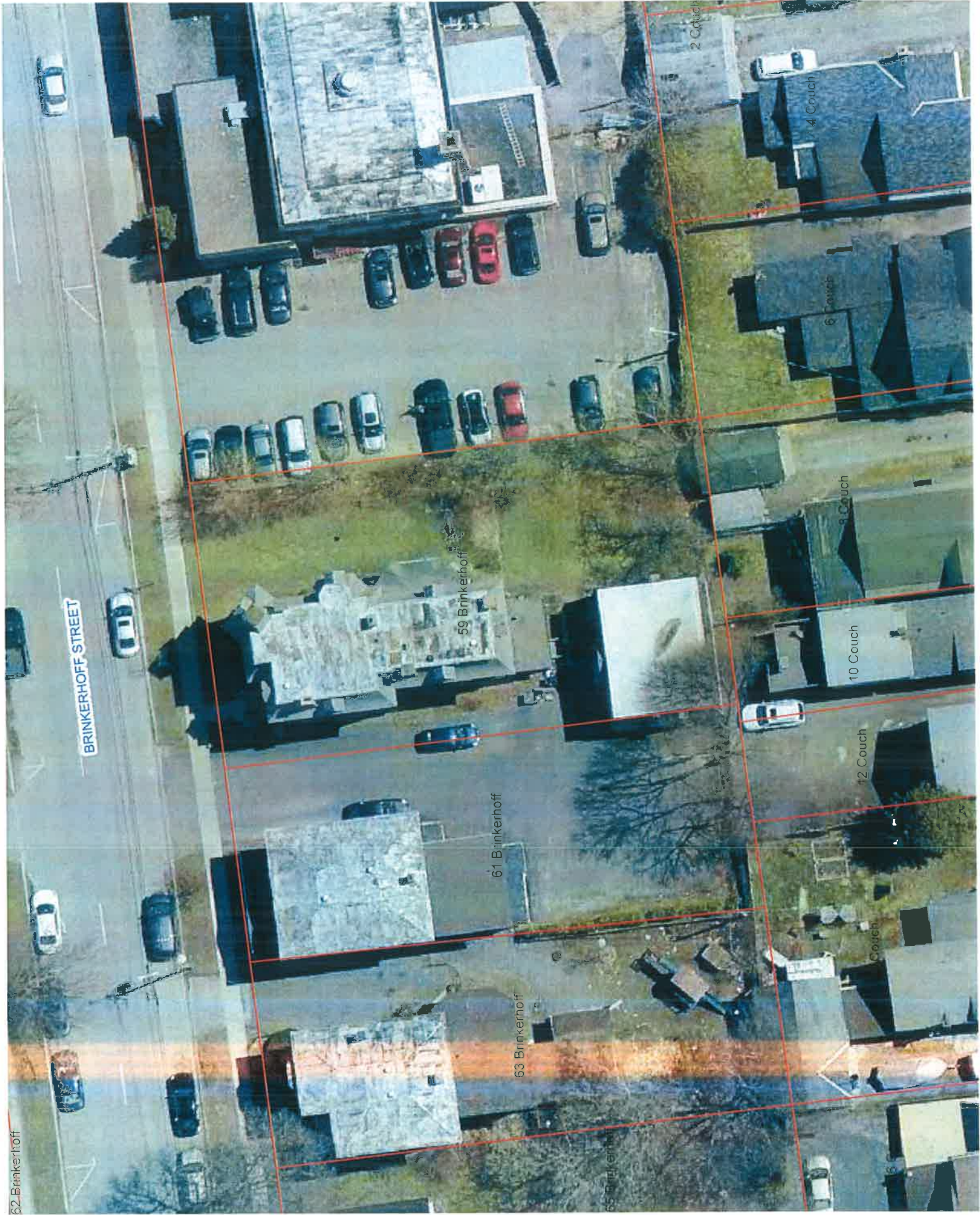
