### **TRAFFIC ZONE DESIGNATION No. 973**

In accordance with Article 39 Section 1640 of the New York State Vehicle and Traffic Law and Chapter 340 of the Code of the City of Plattsburgh, the following traffic control zones are hereby established and/or amended:

A "NO PARKING ANY TIME" zone along the western side of Durkee Street from the intersection of Durkee Street and Broad Street to a point thirty (30) feet north of the northernmost light pole located on the sidewalk in front of 1 Durkee Street. This will replace the existing "10 MIN PARKING 8 AM – 5 PM WEEKDAYS EXCEPT HOLIDAYS" zone on that section of Durkee Street. The dedicated bike lane currently striped in this zone is to be removed and "sharrows" indicating shared use of the roadway by motorists and cyclists are to be added to the adjacent traffic lane.

A "NO PARKING: LOADING ZONE, 7 AM – 7 PM, MONDAY – SATURDAY, 30 MINUTE LIMIT" zone along the western side of Durkee Street between a point twenty (20) feet south of the northernmost light pole located on the sidewalk in front of 1 Durkee Street and a point thirty (30) feet north of the northernmost light pole located on the sidewalk in front of 1 Durkee Street. This will involve the installation of new sign posts. The dedicated bike lane currently striped in this zone is to be removed and "sharrows" indicating shared use of the roadway by motorists and cyclists are to be added to the adjacent traffic lane.

A "NO PARKING ANY TIME" zone along the western side of Durkee Street from a point twenty (20) feet south of the northernmost light pole located on the sidewalk in front of 1 Durkee Street to the southern terminus of Durkee Street where it meets the northern terminus of the new pedestrian bridge across the Saranac River located there. The dedicated bike lane currently striped in this zone is to be removed. Pavement striping in the locations prescribed on the attached map is to be added to Durkee Street to indicate the prohibition on parking in this area.

A "NO PARKING ANY TIME" zone along the eastern side of Durkee Street from the intersection of Durkee Street and Broad Street to the southern terminus of Durkee Street where it meets the northern terminus of the new pedestrian bridge across the Saranac River located there. The dedicated bike lane currently striped in this zone is to be removed and "sharrows" indicating shared use of the roadway by motorists and cyclists are to be added to the adjacent traffic lane.

A "NO PARKING ANY TIME" zone consisting of the entirety of both traffic lanes on Durkee Street from the intersection of Durkee Street and Broad Street to the southern terminus of Durkee Street where it meets the northern terminus of the new pedestrian bridge across the Saranac River located there. This "NO PARKING ANY TIME" zone shall also include any sections of Durkee Street improved as part of the Saranac River Trail, including, but not limited to, those areas of asphalt on Durkee Street replaced by stamped concrete and associated stone work as part of the Saranac River Trail's construction. Pavement striping in the locations prescribed on the attached map is to be added to Durkee Street to indicate the prohibition on parking in this area. This zone is established to prohibit the long standing use of Durkee Street's traffic lanes as parking areas by local businesses in this area.

A visual representation of these traffic zones is included with this order and is overlaid over a map titled "SIGN AND PAVEMENT MARKING PLAN" used for Phase 2 of the Saranac River Trail.

The City's Public Works Department will install the necessary signage and pavement markings in accordance with the NYS Manual of Uniform Traffic Control Devices for the establishment of the above traffic zones.

The establishment of these zones shall become effective upon the erection of the proper signage designating the zones.

All traffic zone designations previously established that are inconsistent with these traffic zone designations are hereby repealed and superseded by these traffic zone designations. All traffic Zones established for other purposes that are consistent with these traffic zone designations shall remain in effect.

BE IT FURTHER RESOLVED, the Common Council finds that this 6-Unit Garage is not needed for a public purpose during the proposed license agreement term, that the payments will not exceed \$5,000 per year, that sufficient notice of availability of the property has been provided to the public, and that Mr. Leclerc submitted the sole proposal.
